Paulo Afonso Amato Condé, the General Representative Mestre, accompanied by his wife, Counselor Léa Condé, by Mestre Roberto Souto Maior and by other authorities from the Center and from Novo Encanto, participated in the 20<sup>th</sup> Expedition to Novo Encanto, which was held from July 16<sup>th</sup> to 21<sup>st</sup>, and which provided a clearer dimension as to how much the União do Vegetal is committed to conserving and preserving that area of forest and of its commitment to Nature.

It was a big celebration in the forest, with over 100 people; days of peace and joy, having the General Representative Mestre emphasizing friendship as the main legacy of this Expedition:

"Besides the experience in the forest, the knowledge of the main trees that are found there, their application and their medicinal uses, bathing in the river, the historical facts from the time of the rubber tappers and the peaceful days spent in contact with nature, the friendship between the participants of the expedition and the organizers of the event grew. They are bonds of friendship to last a

*lifetime,*" said the General Representative Mestre.

Thanks to the infrastructure that exists today, this experience goes far beyond just the trip itself to the lands where Mestre Gabriel had his life as a rubber tapper and where he recreated the União do Vegetal (Seringal Sunta). The expedition is, above all, a journey through the inner universe of each participant.

"Our objective with these expeditions is to make more people realize the importance of environmental conservation and for the associates to become aware of the work that still needs to be done in order to guarantee the preservation of this area," said Mestre José Roberto da Silva Barbosa, President of Novo Encanto.

Novo Encanto, along with the Association of Federal Judges of the 1<sup>st</sup> Region (AJUFER) held, the II Seminar of Amazon Law – Traditional Populations and Environment at the Vila de Alter do Chão (Santarém/PA), on July 26<sup>th</sup> to 28<sup>th</sup>.

The seminar had the objective of promoting the specialized training of Federal Judges for judicial cases regarding the conservation of the

Amazon and the guarantee of the rights of traditional populations.

"The event, which included a technical visit to two traditional communities from the Tapajós National Forest, brought together authorities from three continents, all interested in the preservation of the Amazon Forest. Our objective is to unite forces in order to defend our forests," affirmed Leonardo Pauperio, President of the Association of Federal Judges of the 1<sup>st</sup> Region (CI-Sede Geral).

# **Ayahuasca Culture Day**

In Acre, Governor Tião Viana sanctioned Law Number 3.399, in the July 30<sup>th</sup> edition of the Official Gazette of the State, which instituted Ayahuasca Culture Day, which will be commemorated on November 24<sup>th</sup>; the date that the Letter of Principles by the Religious Entities that use Hoasca Tea was established and signed in 1991.

This Letter, produced after a proposal by the UDV, had Mestre Edson Lodi as one of its creators, whose work was recognized by the Legislative Assembly of Acre and to whom they bestowed the title of Honorary Citizen of the State of Acre.
